

**ASC Fall 1800  
NRA Approved 1800 Conventional Pistol Match and  
CMP EIC Pistol Matches  
Sponsored by the Aurora Sportsmen's Club  
Waterman, IL**

**Saturday, August 10, 2019**

**Who May Compete:** Open to any competitor. In order to enter scores of competitors in the computer classification system, their NRA membership number must be used.

**Range Location:** 1 mile south of Waterman, IL, on Rueff Road between Leland and Waterman Roads.

**Registration Fee:** Registration fee is \$10.00, of which \$4.50 goes to the NRA.

**1800 Match Entry Fee:** \$2.50 per match. Across the board for all 1800 matches, including registration fee, is \$35.00. Advanced entry fee, received 7 days before match day, is \$30.00. Match entries cancelled 7 days before match date will receive full refund. Make checks payable to "Aurora Sportsmen's Club".

**EIC Match Entry Fee:** \$20 per match, \$15 of which goes to the CMP (note, EIC match will be held only if there are at least 6 non-distinguished competitors registered).

**Entries:** Entries will be limited to 28 competitors. Two relays of 14 competitors. Competitors will fire the entire match in one relay. Across the board entries will be given preference in entry and in choice of relay.

There will be a break of 10 minutes between the 22 caliber and center fire matches.

**Rules:** Current NRA/CMP rules will govern all firing. It is the competitor's responsibility to be familiar with such rules as well as those imposed by the Match Director. Competitors will score and change targets. Bring your stapler.

**Challenges:** Challenge fee is \$2.00. A jury system will be used. Plug-type scoring gauges will be restricted to range personnel only.

**Equipment:** Eye & ear protection is required.

- **NRA 1800:** .22 Caliber Pistol or Revolver; Center Fire Pistol or Revolver (NRA Conventional Pistol Rules, sections 3.4 and 3.2, respectively).
- **EIC Service Pistol Match:** (CMP Competition Rules, sections 6.3 and 7.3) .
- **CMP .22 Rimfire Pistol EIC Match:** (CMP Competition Rules, sections 6.4 and 7.3)

**Classification:** NRA classification system will be used for the NRA1800. Unclassified competitors will fire in the master class.

**Categories:** For the NRA 1800, Classes will be grouped as follows: 1) Master / Expert; 2) Sharpshooter; 3) Marksman.

**Facilities:** 14 firing points. Firing line is tables in open air on bare ground. Targets are rotating, but manually operated by the line officer. Pit toilet and port-a-potties nearby. Water will be available for purchase. A BBQ Brat/Polish lunch will be available for purchase at the range.

**Course of Fire (NRA 1800 – Open Division only) :**

- Match 1: 22 caliber, 20 shots, Slow Fire, at 50 yards, B6 target
- Match 2: 22 caliber, 30 shots, NMC (10 shots SF at 50 yards, 10 shots TF at 25 yards, 10 shots RF at 25 yards).
- Match 3: 22 caliber, 20 shots, Timed Fire, at 25 yards, B8 target
- Match 4: 22 caliber, 20 shots, Rapid Fire, at 25 yards, B8 target
- Match 5: Aggregate of matches 1, 2, 3, and 4.
- Match 6: Center Fire, 20 shots, Slow Fire, at 50 yards, B6 target
- Match 7: Center Fire, 30 shots, NMC (10 shots SF at 50 yards, 10 shots TF at 25 yards, 10 shots RF at 25 yards).
- Match 8: Center Fire, 20 shots, Timed Fire, at 25 yards, B8 target
- Match 9: Center Fire, 20 shots, Rapid Fire, at 25 yards, B8 target
- Match 10: Aggregate of matches 6, 7, 8, and 9.
- Match 11: Grand Aggregate – Aggregate of matches 5 and 10.

**Course of Fire (CMP Service Pistol EIC Match):**

- NMC (10 shots SF at 50 yards, 10 shots TF at 25 yards, 10 shots RF at 25 yards).
